Jan 25, 2023 · Basic Qualifying Rules. To qualify for the EITC, you must: Have worked and earned income under \$57,414. Have investment income below \$10,000 in the tax year 2021. Have a valid Social Security number by the due date of your 2021 return (including extensions) Be a U.S. citizen or a resident alien all year.
