Those who dared to come faced hostility and deprivation. This is the country where a native indigenous person had to apply for permission to dress like a Spaniard, and an Ecuadorian was not a citizen if he was not a Catholic. Here is where a customs official boasted that "as long as Mount Chimborazo stands the Bible will not enter Ecuador." It was not until 1895 that foreign missionaries were allowed on its soil. This is the story of some of those people. It is a tribute to the faithful men and women who risked their lives in order to establish the evangelical church in Ecuador. There are stories of persistence and meagre beginnings in some of the most isolated places till a national church arose that is today a formidable missionary force in its own right. It is the story of the people who came, and who came to stay. Ecuadorian writers who understood the milieu into which they were coming provide the historical backdrop for the story. The book foreword is written by the president of the Ecuadorian confraternity of evangelical churches, Eduardo Lopez who says that "AS EVANGELICAL CHRISTIANS IN ECUADOR we ought to be grateful to God for the life and testimony of the first missionaries who came to our nation for the solitary purpose of sharing the Gospel of Christ with Ecuadorians. As a participant in the drama he offers insights and insider perspective on what was happening and had access to C&MA mission files during the investigation. Daybreak over Ecuador is part of his journey and is a tribute to the men and women of the Gospel Missionary Union, the Christian and Missionary Alliance, and many others who spent their lives in the face of great opposition to establish the evangelical church in Ecuador.
