WEBFLEXIBLE SPENDING ACCOUNT (FSA) AN ARRANGEMENT THROUGH YOUR EMPLOYER THAT LETS YOU PAY FOR MANY OUT-OF-POCKET MEDICAL EXPENSES WITH TAX-FREE DOLLARS. ALLOWED EXPENSES INCLUDE INSURANCE COPAYMENTS AND DEDUCTIBLES, QUALIFIED PRESCRIPTION DRUGS, INSULIN, AND MEDICAL DEVICES. YOU DECIDE HOW MUCH TO PUT IN AN FSA, UP TO A LIMIT SET BY YOUR EMPLOYER.

## ELIGIBLE EXPENSES - FSAFEDS

WEBAN FSA (OR FLEXIBLE SPENDING ACCOUNT) IS AN EMPLOYER-SPONSORED HEALTHCARE BENEFIT THAT ALLOWS EMPLOYEES TO SET ASIDE UP TO \$2,850 (2022) ANNUALLY TO COVER THE COST OF QUALIFIED MEDICAL EXPENSES. IT'S A LOT LIKE A SAVINGS ACCOUNT BUT USED FOR QUALIFIED HEALTH-RELATED COSTS.

WEBJAN 13, 2022 · AN FSA IS A TYPE OF SAVINGS ACCOUNT THAT ALLOWS EMPLOYEES TO CONTRIBUTE A PORTION OF THEIR REGULAR EARNINGS TO PAY FOR HEALTH-RELATED COSTS. FUNDS CONTRIBUTED TO THE ACCOUNT ARE DEDUCTED FROM...

WEBA FLEXIBLE SPENDING ACCOUNT (FSA, ALSO CALLED A “FLEXIBLE SPENDING ARRANGEMENT”) IS A SPECIAL ACCOUNT YOU PUT MONEY INTO THAT YOU USE TO PAY FOR CERTAIN OUT-OF-POCKET HEALTH CARE COSTS. YOU DON’T PAY TAXES ON THIS MONEY. THIS MEANS YOU’LL SAVE AN AMOUNT EQUAL TO THE TAXES YOU WOULD HAVE PAID ON THE MONEY YOU SET ASIDE.

WEBA HEALTH CARE FSA (HCFA) IS A PRE-TAX BENEFIT ACCOUNT THAT’S USED TO PAY FOR ELIGIBLE MEDICAL, DENTAL, AND VISION CARE EXPENSES THAT ARE NOT COVERED BY YOUR HEALTH CARE PLAN OR ELSEWHERE. WITH AN HCFA, YOU USE PRE-TAX DOLLARS TO ...
