The Memetics of Music Steven Jan 2017-07-05 Richard Dawkins's formulation of the meme concept in his 1976 classic *The Selfish Gene* has inspired three decades of work in what many see as the burgeoning science of memetics. Its underpinning theory proposes that human culture is composed of a multitude of particulate units, memes, which are analogous to the genes of biological transmission. These cultural replicators are transmitted by imitation between members of a community and are subject to mutational-evolutionary pressures over time.
